| 1: Go EAST on W 13 MILE RD | 0.79 miles |
| 2: Turn RIGHT onto ORCHARD LAKE RD. | 1.08 miles |
| 3: Merge onto 1-696 W/ WALTER P REUTHER FRWY toward LANSING | 3.24 miles |
| 4: Merge onto 1-96 W toward LANSING | 118.80 miles |
| 5: Take the M-6 W exit number 46 toward M-37 | 1.08 miles |
| 6: Merge onto MI-6 W/ PAUL B HENRY FRWY | 3.16 miles |
| 7: Take the M-37 exit number 15 toward HASTINGS/GRAND RAPIDS | 0.42 miles |
| 8: Merge onto MI-37 South (left toward CALEDONIA / HASTINGS) | 7.00 miles |
| 9: Turn SLIGHT RIGHT onto N CHERRY VALLEY RD | 5.23 miles. |
| 10: N CHERRY VALLEY RD becomes BASS RD/ CR 436 | 0.40 miles. |
| 11: Turn LEFT onto N BRIGGS RD | 1.03 miles |
- 12: Right turn in to main entrance of YMCA Camp Manitou-Lin. Parking is also available at the performance field. To park at the field, pass the main camp entrance and take first entrance on the left (located at the next bend in the road.)

ESSENTIAL CAMP INFORMATION FOR PARENTS

General Camp Regulations:

- All Farmington Public School policies and procedures apply to all aspects of camp.
- Any use of alcohol, controlled substances, unauthorized use of prescription medicine, tobacco or other items outlined on the Farmington Public Schools Student Code of Conduct is forbidden.
- No student may leave their cabin following lights-out.
- Absolutely no males in female cabins; absolutely no females in male cabins.

Disciplinary Measures:

- Appropriate disciplinary measures will be taken in accordance with FPS guidelines.
- If, in the judgment of the Director, the matter is serious enough, the student may be removed from camp:
 - Student's parents will be contacted immediately to get their child.
 - If that is not possible, student will be returned home at family's expense.
- A student leader whose behavior does not set a positive example may forfeit his/her position for the season.

Medical Information:

- All prescription and over-the-counter medications MUST be placed in a ziploc bag with student identification and given to Health Official at camp check-in.
- Prescriptions must be in original containers with prescription information on the label.
- Over the counter medications must have the student's name on the container or bottle.
- Michigan law requires that Health Official:
 - dispenses & records all medications taken and when
 - keep medications in locked cabinet for controlled access
- Students are allowed to keep bee sting kits & inhalers on their person in case of severe reaction.
- Health Official will be available to speak with parent or guardian at camp check-in.
- Health Official will determine medication times in accordance with doctor's instructions.

Visitations:

- Visitors may attend the Preview Performance on Saturday at 1:00 pm.
- Any other visitation is discouraged.
- If visitation is necessary during the week, you must check in with the Director and with YMCA Camp staff.

Americans with Disabilities Act:

- In compliance with the Americans with Disabilities Act, the North Farmington High School Band and Orchestra program will not discriminate against any individual on the basis of physical or mental impairment with respect to participating in the organization's activities.
